

1.	Display of election schedule on Notice Board/Website with a copy to Regulator of Trade Organizations	10-07-2024 Wednesday
2.	Changes, if any, regarding name of representative appearing in the list of voters shall sent to the Secretary General along with necessary proof of eligibility within three days of the announcement of Election Schedule.	13-07-2024 Saturday
3.	Secretary General shall display within seven days of the announcement of Election Schedule the provisional list of all members eligible to vote along with their national tax number, sales-tax-registration number, if applicable, the name and national identity card number of their representative	17-07-2024 Wednesday
4.	The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary General within seven days of the issuance of the voters' list.	23-07-2024 Tuesday
5.	Intimation of action on the objections by the Secretary General within five days from receipt of objections.	27-07-2024 Saturday



6.	Person aggrieved by the decision of the Secretary General may make a representation, within three days	30-07-2024 Tuesday
7	Election Commission which shall decide the representation within three days.	02-08-2024 Friday
8.	Appeal against the decision of the Election Commission or in case the Election Commission fails to decide within the stipulated time provided under preceding clause any person aggrieved by its decision may appeal to the Regulator of Trade Organizations within three days.	05-08-2024 Monday
9	The Regulator TOs decide the appeal within ten days. Decision of Regulator of Trade Organizations (shall be deemed to be final)	15-08-2024 Thursday
10.	Within two days of the decision of the Regulator the final voters' list shall be issued.	17-08-2024 Saturday
11.	Within four days of the display of the final list of voters' any person who is eligible to contest the elections for the vacant post, shall send his nomination to the Secretary General duly proposed and seconded by a duly registered voter and signed by the candidate.	21-08-2024 Wednesday
12.	Within twenty-four hours of receipt of nomination papers, a copy of the final list of voters' shall be provided to each contesting.	22-08-2024 Thursday



13.	The nomination papers shall be scrutinized and list of candidates shall be displayed within twenty-four hours of the last date of receipt of nomination papers.	23-08-2024 Friday
14.	The objections, if any, to the nomination of the candidates can be filed to the Election Commission within twenty-four hours of issuance of the list of candidates	24-08-2024 Saturday
15.	Decision of Election Commission within two days	26-08-2024 Monday
16.	Any candidate aggrieved by the decision of the Election Commission may file appeal to the Regulator within two days,	28-08-2024 Wednesday
17	The Regulator TOs decide the appeal within seven days. Decision of Regulator of Trade Organizations which shall deemed to be final	05-09-2024 Thursday
18.	Withdrawal of Nominations.	06-09-2024 Friday
19.	Within two days of the decision of the Regulator the Election Commission shall issue the final list of candidates.	08-09-2024 Monday
20.	Within five days of display of final list of candidates, the election of Members of Executive Committee will be held.	12-09-2024 Thursday



21.	Within two days of the election, any person elected as Members of Executive Committee shall send his nomination for election as an Office Bearers (Chairman Senior Vice Chairman, and Vice Chairman) duly proposed and seconded by an elected Executive Committee member and signed by the candidate to the Election Commission.	14-09-2024 Saturday
22.	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty four hours of the last date of receipt of nomination papers.	16-09-2024 Monday
23.	Within two days of display of final list of candidates, the polling for election of Office Bearers (Chairman, Senior Vice Chairman, and Vice Chairman) shall be held.	18-09-2024 Wednesday
24.	The final result shall be officially announced at the Annual General Meeting of the Association.	28-09-2024 Saturday

**IMPORTANT TO NOTE**

Although the expected and declared holidays have been mentioned in Election Schedule However, in case of any holiday(s) falling on any of the above working days of the Election Schedule, the next working day would be automatically treated as the new date.

The election will be conducted on the all seats of the Executive Committee.
